Course Description

A practical application of health-related statistical analysis providing students with the knowledge and skills needed to read, interpret, and evaluate quantitative findings in medical and allied health literature.

Student Learning Outcomes

Upon completion of this course, students will be able to:

1. Describe the historical, current, and future need for environmental health science as a field of study, from a scientific, practical, and personal perspective.
2. Explain what environmental health is, what distinguishes it from the other health sciences, and what unique contributions it has to make to the field of health
3. Identify chemical and physical hazards in a range of common environments and describe the pathways by which humans are exposed to chemical and physical agents.
4. Identify ways in which the public health hierarchy of controls can be applied to reduce or eliminate a variety of environmental and occupational hazards.
5. Recognize adverse health effects associated with common environmental and occupational stressors.
6. Identify risk assessment approaches to integrate sources, exposure pathways, and adverse health outcomes.
7. Identify the principal environmental determinants of health and describe the major environmental health issues of the present time.
8. Identify environmental health issues specific to sensitive and vulnerable populations, including environmental health in a global setting.
9. Find and apply information relevant to the environmental health sciences.
10. Describe important emerging and future issues in environmental health.

Course Delivery

This course of the face-to-face instructional format. It will meet on campus. Most content will be delivered via class or online lectures/videos, discussions and course assignments. Teaching Strategies

Students are expected to be “active learners.” It is a basic assumption of the instructor that students will be involved (**beyond the materials and lectures presented in the course**) discovering, processing, and applying the course information using peer-review journal articles, researching additional information and examples on the Internet, and discussing course material and clinical experiences with their peers.

Assignment and Activity Descriptions

Exams: Access to the Midterm and Final Exam will be through Respondus Lockdown Browser and will be video recorded via Respondus Monitor [See Other Required Materials for a list of needed equipment]. Both will be timed at no more than 120 minutes. Use of notes, book, another electronic device, or any other form of assistance is prohibited.

Readings: You are responsible for the material covered in the book. Please note that the week's readings are specified in the class pacing schedule posted on Blackboard. In addition to these readings, the instructor may assign supplemental readings throughout the semester. These supplemental readings do not appear on the schedule, as these readings will be assigned at the instructor's discretion.

Quizzes: Weekly online quizzes will be given throughout the semester and will require that you read and respond to material in the textbook as well as revisit topics discussed in class. Access to quizzes will be through Respondus™ Lockdown Browser [see Other Required Materials for a list of needed equipment] via Blackboard. Students may use written materials as well as their textbook; however, use of another electronic device is prohibited.

There is a *Readiness Quiz*, which will serve as a webcam test and will give you an opportunity for bonus points. These tools will be available to the student to assure accessibility. Students will have multiple (3) attempts to complete the practice quiz. This process will allow you to become familiar with the technology associated with testing and improve testing environment. Instructional videos and more information regarding Respondus Monitor can be found under the Respondus Monitor Help tab in your Blackboard course.

Homework: Students will be responsible for the completion of ten (10) written assignments. The purpose of these assignments is to assist students in applying their understanding of environmental health topics discussed in class as to well as to provide an opportunity for students to respond to the readings. These short essays are to be written in APA format, standard 12-point Times New Roman font, double-spaced with 1-inch margins.

Writing Center

The mission of the [Writing Center](#) is to help all students become better writers and readers. The Writing Center is a peer tutoring service where students help students. It is staffed by specially selected and trained graduate assistants and peer tutors who offer one-on-one conferences about writing and reading. Citations

You must properly cite any work that is not completely your own. It is understood that you will build on the ideas of others through research, reading, and collaboration, but failure to acknowledge the scholarship of others is plagiarism and an honor code violation. It is also understood that you should use direct quotes sparingly. In this course, we would like you to use the Publication Manual of the American Psychological Association, Sixth Edition.
