Welcome to the College of Education's **application for student teaching**. A valid ASU e-mail address is required to submit this application, and correspondence about acceptance and placement will be electronic.

The information you provide will be confidential, and you are free to change and update the data by contacting the College of Education's Field Experience Office. All of the information you provide must be accurate to your knowledge; falsification of answers are grounds for rejection to student teach for the semester you have applied.

When you are finished with your application, it is your responsibility to make sure the College of Education's Field Experience Office has each of the following:

1. One copy of RAMS online Degree Evaluation with student grades visible.
2. A copy of your e-mail confirmation application receipt from the Office of Field Experience.
3. For Post-bac certification candidates, a current copy of filed certification plan.
4. One original "Statement of Philosophy" on education and completed biographical data information.
5. Completed criminal history release form with all questions answered and original signature (in ink).
6. IF applicable for your circumstances, Department Head approval forms.
7. IF applicable for your circumstances, correspondence course forms and information.
8. Application agreement forms (to be signed when you submit your entire application).

This application should be **submitted no later than 5:00 p.m. Thursday, March 26, 2009.**

To be considered for Student Teaching in fall 2009, final submission of application and all documents for the fall 2009 semester, correctly completed, must be received by the Office of Field Experiences, Carr Building, Room 206, 325-942-2520, by 5:00 p.m. Monday, April 6, 2009.
