ASU Activity Card

What you get...

- ! Football Season Tickets (Sections C-D-Upper E)
- ! Basketball Season Tickets (Upper or Lower Level)
- ! General Admission (Baseball, Soccer, Softball, Track and Field, Volleyball)
- ! Drama Productions (*Dinner Theater Tickets will be an additional \$12.50 for each show.*)
- ! Reservation Privileges at Lake Facilities (*other than General Use Hours*)
Class V Rental Rate Option for Private Use of the ASU Lake House
Reservations will only be taken 30 days prior to date requested, based on availability.
- ! Center for Human Performance (*during General Use times*)
(swimming pool, racquetball courts, weight room, gymnasium)
- ! Lake Facilities (*during General Use times*)
- ! ASU SAY Sports Complex (*during General Use times*)
- ! Guest Privileges (4 per cardholder) at Recreation Sites
(Center for Human Performance, Junell Center, ASU SAY Sports Complex, Lake Facilities)
(Age limits applicable at some locations.)



What it costs...

*The IRS requires income and social security tax withholding on the value of sporting and other event tickets provided by colleges to employees to the extent the employee's discount exceeds 20% of the general public's ticket price. Since the discount provided to ASU employees and their families is considerably more than 20%, the employees must pay taxes on the portion of the discount that exceeds 20%. This tax liability is deducted through payroll and spread over three months: Sept., Oct., Nov.

Employees not purchasing an activity card may purchase reserved football and/or basketball season tickets, or other ticket packages, at a 20% discount without tax liability.

All-Sports Season Ticket

What you get...

- * Reserved seats for football, basketball, and baseball
- * General Admission to all other regular season ASU home sporting events

What it costs...

\$132.00 per ticket. There is no tax liability.
(The cost to the general public is \$165.00.)

All-Sports Fun Pass for Four

What you get...

- * Four general admission tickets to all regular season ASU home sporting events
(Children 12 and under must be accompanied by an adult at the games.)

What it costs...

\$105.60 for four general admissions. There is no tax liability.
(The cost to the general public is \$132.00.)

Facility Use Card

What you get...

- * Access to Center for Human Performance
(Swimming pool, racquetball courts, weight room, gymnasium) (during General Use times)
- * Access to Junell Center *(upper weight rooms only) (during General Use times)*
- * Access to Lake Facilities *(during General Use times)*
- * Access to ASU SAY Sports Complex *(during General Use times)*

What it costs...
