Justification: Given the course work available, the popularity of the student-edited literary arts review OASIS, the annual Writers Conference in Honor of Elmer Kelton, and four tenure-track faculty who regularly publish in poetry and fiction, the Department of English believes that an English major with specialization in creative writing is an appropriate option for ASU students.

Course Additions

POLS 3343 Political Economy of Globalization (3-0)

CIP Code: 45.1004.00 01

This course is an introduction to the politics of globalization. It provides students with analytical tools to better understand the multi-dimensions ~~and~~ of globalization and their impact on contemporary world politics. The course also discusses the controversy surrounding the consequences of globalization.

Justification: This course adds critical subject matter to the Political Science program in the heretofore neglected sub-field of Comparative Politics. It helps modernize the curriculum and bring our program in line with larger institutions.

POLS 3347 Politics of China (3-0)

CIP Code: 45.1001.00 01

China is the world's most rapidly growing economy, and it soon will become the second largest economy in the world. It is also the largest and most powerful communist nation in the world. China's extraordinary success in economic reform and the potential political challenges it faces make exploration of the world's most populous country essential for today's students. This course is an introduction to the politics of China. Topics include Chinese communist ideology, the institutions and processes of the Chinese political system, and the significant issues of recent political history.

Justification: This course adds critical subject matter to the Political Science program in the heretofore neglected sub-field of Comparative Politics. It helps modernize the curriculum and bring our program in line with larger institutions.

POLS 4321 Comparative Political Economy (3-0)

CIP Code: 45.1004.00 01

This course is an introduction to comparative political economy with an eye to the influence of political and institutional factors on economic performance. The course will examine, among others, the following questions. (1) Why do countries differ so much in their level of economic development? and (2) Why do countries adopt distinctive economic policies?

Justification: This course adds critical subject matter to the Political Science program in the heretofore neglected sub-field of Comparative Politics. It helps modernize the curriculum and bring our program in line with larger institutions.

POLS 4341 Political Economy of East Asia (3-0)

CIP Code: 45.1004.00 01

Throughout the last half century, East Asia has attracted great scholarly attention with its extraordinary economic growth, political transformation, and the consequent security challenges. This course is designed to provide a comprehensive understanding of politics in the region, paying special attention to the interplay between politics and the economy.

Justification: This course adds critical subject matter to the Political Science program in the heretofore neglected sub-field of Comparative Politics. It helps modernize the curriculum and bring our program in line with larger institutions.

Department of Psychology, Sociology, and Social Work
Psychology - Graduate

Course Additions

PSY 6362 Basic Experimental Methodology (3-0)

CIP Code: 42.0101.00 01

This course will involve a focused treatment of basic methodological skills and knowledge pertaining to I-O psychology, including internal/external validity, sampling theory, scale construction and validation, and basic consultation skills regarding these issues.

Justification: The I-O program is moving to a one-year course rotation, which requires the addition of two courses (PSY 6362 and PSY 6363) as well as the rearrangement of other courses in the curriculum. The one-year rotation will tighten the sequencing of course material, standardize the timing of internship events, and ensure that first-year I-O cohorts have all the essential information they need to complete the internship adequately.

PSY 6363 Advanced Experimental Methodology (3-0)

CIP Code: 42.0101.00 01

This course will involve a focused treatment of advanced methodological skills and knowledge pertaining to I-O psychology, including complex research designs, quasi-experimental designs, time-series designs, and other uncommon approaches.

Justification: The I-O program is moving to a one-year course rotation, which requires the addition of two courses (PSY 6362 and PSY 6363) as well as the rearrangement of other courses in the curriculum. The one-year rotation will tighten the sequencing of course material, standardize the timing of internship events, and ensure that first-year I-O cohorts have all the essential information they need to complete the internship adequately.

MS I/O Psychology

MS I/O Psychology with Thesis Option

CIP Code: 42.2804.00

Thesis or Non-Thesis (42 SCH): The student must complete a minimum of 33 SCHs of psychology course work and 9 additional SCH of graduate-level work in psychology or supportive electives. The psychology courses must include 6313; one course from 6303, 6311, 6341, six courses from 6350, 6352, 6353, 6354, 6355, 6356, 6357, 6358; 6359, 6360, and either six credit hours of thesis (6399 twice or 6699) for students in the thesis option, or six credit hours of practicum (6372 twice or 6672) for students in the non-thesis option. The remaining 12 credit hours, at least three of which must be in psychology, are unspecified but must be approved by the graduate advisor.

The student must complete a minimum of ~~33~~ 36 SCHs of psychology course work and ~~9~~ 6 additional SCH of graduate-level work in psychology or supportive electives. The psychology courses must include: 6313, at least one course from the following list (6303, 6311, 6341); all seven of the following courses (6350, 6352, 6356, 6358, 6360, 6362, 6363); and either six credit hours of thesis (6399 twice or 6699) for students in the thesis option, or six credit hours of practicum (6372 twice or 6672) for students in the non-thesis option. The remaining 9 credit hours, 3 of which must be in psychology, are unspecified and subject to the approval of the graduate advisor."

Justification: The I-O program is moving to a one-year course rotation, which requires the addition of two courses (PSY 6362 and PSY 6363) as well as the rearrangement of other courses in the curriculum. The one-year rotation will tighten the sequencing of course material, standardize the timing of internship events, and ensure that first-year I-O cohorts have all the essential information they need to complete the internship adequately.

Psychology, Sociology, and Social Work - Undergraduate

Dr. Carr led the discussion about the changes to the Social Work program in an effort to meet accreditation requirements. Question about PSY 4327 being deleted were raised. Students will be able to take SWK 4327 since PSY 4327 is being deleted. Prerequisites will be added to the SWK 4309 curriculum change form as listed below. A motion to approve by Dr. Lambert and seconded by Dr. Gates.

SWK 2317 Social Welfare Policy and Practice I (3-0)

CIP Code: 44.0701.00 09

Provides knowledge and values of the history and philosophy of social welfare programs and the skills to understand major social welfare policies. The impact of policy on human functioning is also emphasized.

Justification: This course is being moved from a 3000 level course to a 2000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements.

SWK 3307 Human Behavior in the Social Environment I (3-0)

CIP Code: 44.0701.00 09

The biopsychosocial science base of social work practice. Includes theories of biological, social, cultural, psychological, and spiritual development within the context of the social environment through the life course. Focuses on the critical evaluation and application of theories and knowledge to person-environment transactions.

Prerequisites: Social Work 2307, Social Work 2317, and admission into the Social Work degree program or a declared Social Work minor.

Justification: This course is being moved from a 2000 level course to a 3000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements.

Prerequisite changes for the same reasons.

SWK 3309 Social Work Practice I (3-0)

CIP Code: 44.0701.00 09

The introduction to social work practice with individuals, couples, families and small groups, including the use of communication skills, supervision, and consultation. Focuses on engagement, assessment and evaluation, planning for service delivery, implementing empirically based interventions, and evaluating outcomes.

Prerequisites: Social Work 2307, Social Work 2317 and Admission into the Bachelor of Social Work degree program

Prerequisite or Corequisite: Social Work 3307

Justification: This course is being moved from a 2000 level course to a 3000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements.

Prerequisite changes for the same reasons.

SWK 3311 Human Behavior in the Social Environment II (3-0)

CIP Code: 44.0701.00 09

The biopsychosocial science base of social work practice. Includes a critical analysis of the interactions between the person and the dynamic nature of groups, organizations, communities, society, and economic systems. Focuses on multiple dimensions of the person and the range of social systems in which they live.

Prerequisites: Social Work 3307 and Social Work 3309

Justification: This course is being moved from a 2000 level course to a 3000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements.

Prerequisite changes for the same reasons.

SWK 3313 Social Work Practice II (3-0)

CIP Code: 44.0701.00 09

The introduction to social work practice with large groups, organizations, and communities, including the use of communication skills, supervision, and consultation. Focuses on engagement, assessment and evaluation, planning for service delivery, implementing empirically based interventions, and evaluating outcomes.

Prerequisites: Social Work 3307 and Social Work 3309

Justification: This course is being moved from a 2000 level course to a 3000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements.

Prerequisite changes for the same reasons.

SWK 3315 Social Welfare Policy and Practice II (3-0)

CIP Code: 44.0701.00 09

Provides the knowledge, skills, and values to apply social welfare policy and practice. Focuses on policy analysis, implementation of policy to achieve social and economic justice, and the impact of social policy on the social work profession.

Prerequisites: Social Work 2307, Social Work 2317, and Admission to the Bachelor of Social Work degree program.

Justification: This is a new course pursuant to the recommendations of the Council on Social Work Education. It is the continuation of Social Work 2317 and restricted to B.S.W. majors.

SWK 3355 Social Work Research Methods I (3-0)

CIP Code: 44.0701.00 09

Presentation of the methods used in scientific inquiry and program evaluation; knowledge of how scientific evidence informs social work practice and how social work practice informs scientific inquiry is of primary concern. Focuses on the skills related to conducting research and practice evaluation. Ethical, cultural, and professional value considerations in the research process are emphasized.

Prerequisites: Social Work 2307, Social Work 2317, and Admission to the B.S.W. degree program.

Justification: This course is being created because SWK can no longer use the SOC/SWK 3325 Social Research and Data Analysis course taught by sociology. This course will focus on research methods vice statistical analysis.

SWK 3357 Social Work Research Methods II (3-0)

CIP Code: 44.0701.00 09

Presentation of selected statistical methods used in scientific inquiry, program evaluation, and knowledge of how statistical analysis informs social work practice. Focuses on the skills related to statistical analysis, interpretation, and application. Ethical, cultural, and professional value considerations in statistical analysis are emphasized.

Prerequisite: Social Work 3355.

Justification: This course is being created because SWK can no longer use the SOC/SWK 3325 Social Research and Data Analysis course taught by sociology. This course will focus on statistical analysis, interpretation, and application vice research methods.

SWK 4309 Social Work and Health Care (3-0)

CIP Code: 44.0701.00 09

Provides knowledge and skills necessary for generalist social work practice in a hospital and other health care settings with people from diverse backgrounds. Topics include an introduction to evidence-based practice in health care environments, medical terminology, and biopsychosocial factors relating to physical illness and disease. Promotes the application of social work values, ethics, and standards in physical health care.

Prerequisites: [Social Work 2307](#) and [Social Work 2317](#).

Justification: This course is being created to provide for an appropriate number of elective courses for social work majors and minors per the recommendation of the Council on Social Work Education.

SWK 4317 Social Work and Case Management (3-0)

CIP Code: 44.0701.00 09

An in-depth analysis of the case management process from a generalist perspective. Focuses on evidence-based practices in contemporary case management, clarification of practitioner attitudes, cultural competence, effective communication skills, client assessment, service plan development, case documentation, the monitoring of services and treatment, and case termination.

Prerequisites: Social Work 2307 and Social Work 2317.

Justification: This course is the recreation of the old SWK 3345 Social Work Practice III which is being deleted. However, this new course is not required, is an elective, and is being renumbered to be consistent with the Council on Social Work Education's recommendations.

SWK 4373 Social Work Practice III (3-0)

CIP Code: 44.0701.00 09

The integrative seminar in social work. This capstone course facilitates the integration and application of the generalist social work curriculum in diverse, evolving, and emerging practice contexts. Student career development, use of technology, and professional leadership are emphasized. As a part of this course, students must take and pass a comprehensive examination.

Prerequisite: Social Work 4371.

Justification: This course is being created at the recommendation of the Council on Social Work Education. We are also moving the comprehensive examination into this course structure as opposed to having a stand-alone exam.

Course Deletions

PSY 4327 Human Sexuality (3-0)

CIP Code: 42.0101.00 01

Justification: The Council on Social Work Education (CSWE) recommended that social work no longer offer cross listed courses. This course will still be offered as SWK 4327 Human Sexuality in the Social Work Program.

SOC 4325 Correctional Case Management (3-0)

CIP Code: 45.1101.00 01

Justification: This course was once cross listed with SWK 4325 Correctional Counseling and Rehabilitation (Correctional Case Management) to support the Criminology and Deviant Behavior concentration in sociology. The Criminology and Deviant Behavior concentration no longer exists and the course material is no longer relevant to sociology.

SOC 4327 Human Sexuality (3-0)

CIP Code: 45.1101.00 01

Justification: This course was once cross listed with SWK 4327 to support the Family and Life Course concentration in sociology which no longer exists. The Council on Social Work Education (CSWE) recommended that social work no longer offer cross listed courses. This course will still be offered as SWK 4327 Human Sexuality in the Social Work Program.

SWK 2309 Human Behavior in the Social Environment I (3-0)

CIP Code: 44.0701.00 09

Justification: This course is being moved from a 2000 level course to a 3000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements.

SWK 3307 Human Behavior in the Social Environment I is being created to take SWK 2309 Human Behavior in the Social Environment's place.

SWK 2311 Human Behavior in the Social Environment II (3-0)

CIP Code: 44.0701.00 09

Justification: This course is being moved from a 2000 level course to a 3000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements.

SWK 3311 Human Behavior in the Social Environment II is being created to take SWK 2311 Human Behavior in the Social Environment II's place.

- SWK 2313 Social Work Practice I (3-0)**
CIP Code: 44.0701.00 09
Justification: This course is being moved from a 2000 level course to a 3000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements. SWK 3309 Social Work Practice I is being created to take SWK 2313 Social Work Practice I's place.
- SWK 2315 Social Work Practice II (3-0)**
CIP Code: 44.0701.00 09
Justification: This course is being moved from a 2000 level course to a 3000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements. SWK 3313 Social Work Practice II is being created to take SWK 2315 Social Work Practice II's place.
- SWK 3303 Social Welfare Policy and Practice (3-0)**
CIP Code: 44.0701.00 09
Justification: This course is being moved from a 3000 level course to a 2000 level course per the request of the Council on Social Work Education in efforts to meet accreditation requirements. SWK 2317 Social Welfare Policy and Practice I is being created to take SWK 3303 Social Welfare Policy and Practice's place.
- SWK 3305 Social Work Ethics and Professionalism (3-0)**
CIP Code: 44.0701.00 09
Justification: The material content of this course will be integrated throughout the social work curriculum per CSWE requirements.
- SWK 3325 Social Research and Data Analysis (3-0)**
CIP Code: 44.0701.00 09
Justification: The material content of this course will be presented in two new courses, Social Work Research I (Methods) and Social Work Research II (Statistics) per CSWE site reviewer recommendation. SOC 3325 Social Research and Data Analysis will remain unchanged.
- SWK 3327 Human Diversity and Social Inequality (3-0)**
CIP Code: 44.0701.00 09
Justification: The material content of this course will be integrated throughout the social work curriculum per CSWE requirements. SOC 3327 Human Diversity and Social Inequality will remain unchanged.
- SWK 3341 Juvenile Delinquency (3-0)**
CIP Code: 44.0701.00 09
Justification: The SWK content of this course will be merged with an existing course, SWK 4325 Correctional Counseling and Rehabilitation. SOC 3341 Juvenile Delinquency will remain unchanged.
- SWK 3343 Criminology (3-0)**
CIP Code: 44.0701.00 09
Justification: The SWK content of this course will be merged with an existing course, SWK 4325 Correctional Counseling and Rehabilitation. SOC 3343 Criminology will remain the same.
- SWK 3345 Social Work Practice III (3-0)**
CIP Code: 44.0701.00 09
Justification: This course is being deleted, recreated, and renumbered as an elective course.

Justification: This is a course name change without change in content and an addition of another prerequisite course. This change is to be consistent with the other Social Work electives and pursuant to CSWE recommendations. SWK 4325 Correctional Counseling and Rehabilitation (3-0) (Title, Description, and Pre-req change)

CIP Code: 44.0701.00 09

A study of the various treatment and rehabilitation methods used in correctional settings. Topics include the roles of correctional personnel, the assessment and treatment of juveniles and adults, casework in correctional settings, crisis intervention, the assessment and treatment of special populations in correctional settings, and the evaluation of treatment and rehabilitation programs. (Credit may not be earned for this course and Sociology 4325.)

Prerequisite: Psychology 2301 or Sociology 2301 or Social Work 2307 or Sociology 2307.

A study of the various treatment and rehabilitation methods used in correctional settings with diverse populations. Topics include the roles of correctional personnel, the assessment and treatment of juveniles and adults, casework in correctional settings, crisis intervention, the assessment and treatment of special populations in correctional settings, and the evaluation of treatment and rehabilitation programs.

Prerequisite: Social Work 2307 and 2317.

Justification: This is a course name and description change without change in content and an addition of another prerequisite course. This change is to be consistent with the other Social Work electives and pursuant to CSWE recommendations. Social Work 2317 is being added as an additional prerequisite pursuant to CSWE recommendations.

SWK 4327 Human Sexuality (3-0) (Title and Cross-listing change)
