August 2013 - present:

Adjunct Instructor, *Angelo State University, San Angelo, Texas*. Teach upper level undergraduate course (lecture and lab) in Range Wildlife Management (RWM 4333).

August 2012 - present:

Private Wildlife Consultant, *Habitat Advantage LLC. and Wildlife Consultants, LLC, San Angelo, Texas*. Current owner and co-owner operator of two Wildlife Consulting firms. Provide full service wildlife habitat and species management consultation to clients in Texas, Mississippi, Arkansas, Louisiana, and Mexico.

December 1997 - July 2012:

Regional Director, *Texas Parks and Wildlife Department, San Angelo, Texas*. Plan and supervise and administrate all activities and programs (Regulatory, Wildlife Management Areas, Technical Guidance, Waterfowl, Interpretive, Urban and Diversity) of Texas Parks and Wildlife Department Wildlife Region I (Trans-Pecos and Panhandle, encompassing approximately 56 million acres) and its staff of 43 wildlife biologists, technicians and support staff, developing and implementing a \$2.4 million budget, conducting all personnel actions and overseeing operation of 10 wildlife management areas; serve as a member of the Department's Wildlife Division's Senior Staff and sit on various conservation working committees; review and edit Regulation proposals, Federal Aid documents, Farm Bill projects, Landowner Incentive Project proposals and Section reports, prepare and deliver presentations and training seminars for Regional staff and conservation/landowner groups, currently provides technical guidance to 13 landowners on 20 ranches affecting 290,000 acres. Other responsibilities include coordinating Wildlife Division personnel issues, computer inventory and annual purchasing, developing and writing escrow guidelines, and co-coordinating the summer intern program. Served as a mentor for the Natural Leaders Program.

December 2008-December 2009:

Acting, Wildlife Division Deputy Director for Administration, *Texas Parks and Wildlife Department, Austin, Texas*. Served at the direction of the Acting Division Director in assisting with direction and leadership of the Wildlife Division. Responsible for the oversight and coordination of day to day operations of the Division in the absence of the Director. Provides direct supervision to six staff and oversight for administrative services, to include human resources, international relations, budget management, policy, Section 6, Research and Analysis, State Wildlife Action planning and Federal Aid.

October 1989 - December 1997:

Technical Guidance Biologist, *Texas Parks and Wildlife Department, San Angelo) and Alpine, Texas*. Work directly with 54 private land managers formulating wildlife habitat and

population management plans/recommendations on 1.3 million acres throughout western Texas. Plan and recommend wildlife management and habitat enhancement activities on Department owned land. Act as team leader to coordinate management activities within the Trans-Pecos ecological area. Plan, coordinate, and conduct the collection and analysis of data concerning the population dynamics, distribution, and life history of wildlife species as needed. Provide in-service training to TPWD personnel. Conduct wildlife management workshops, seminars and clinics for the general public. Disseminate wildlife management information to the general public in the form of printed material, news releases and oral presentations. Communicate, interact, and conduct public relations work with inter- and intra- Departmental, federal, and private resource/conservation organizations, academic institutions, the public, and the news media regarding Department programs and activities. Additional duties include administrating and participating in the Private Lands Enhancement Program, Farm Bill Program, Texas Lone Star Stewardship Awards Program, and the Texas Private Lands Initiative for the Trans-Pecos ecological area.

January 1995 - May 1995:

Legislative Liaison, *Texas Parks and Wildlife Department, Austin, Texas*. Served as Wildlife Division's legislative liaison and point of contact for legislators. Reviewed proposed legislation for potential impact to wildlife resources and their habitats and coordinated review with other Divisions. Designated appropriate staff to prepare bill and fiscal analyses. Prepared bill analyses when staff was not present. Developed proposed legislative needs, coordinated information transfer for legislative representatives, scheduled meetings between staff and legislative representatives and coordinated resource witnesses' presence at legislative public hearings. Served as Wildlife Division resource witness at legislative hearings when appropriate.

October 1984 - September 1989:

Regulatory Wildlife Biologist, *Texas Parks and Wildlife Department, San Angelo, Texas*. Managed and researched wildlife species occurring in the Possum Kingdom Regulatory District of North Central Texas. Inventoried wildlife resources and habitat; collected and analyzed biological data pertinent to population conditions and harvest; conducted literature and field research; trapped and transplanted wildlife; prepared technical reports and disseminated wildlife research and management information to landowners. Developed wildlife and habitat research and management proposals. Reviewed regulations proposals and acted as wildlife resource witness at public hearings. Work directly with 45 private landowners/managers during this time controlling in excess of 600,000 acres developing wildlife management plans and written recommendations. Supervised co-workers on special projects as directed by District Leader.

Range Conservationist (Rangeland Specialist), *USDA, Soil Conservation Service (now Natural Resources Conservation Service), Ballinger (summer trainee), Crowell and Memphis, Texas*. Coordinated and administered the Resource and Conservation and Development Program, and related Farm Bill Programs like the Watershed Program, Great Plains Conservation Program, Long-Term Agreement Program and the Agricultural Conservation Program. Served as acting District Conservationist at the Memphis field office from 6/82 - 10/82 and conducted performance reviews and annual evaluations for five employees. Developed field office annual plans of operations, reports, training schedules and budgets.
