Institutional Characteristics Overview

Common Errors

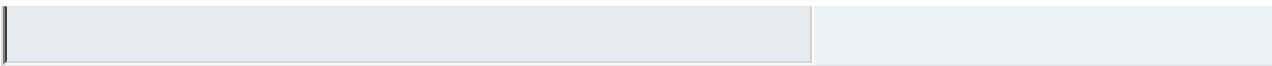
