Course Description

The purpose of this course is to introduce basic aural skills concepts within the realm of tonal music. Numerous *Auralia* assignments and singing exams will be used to assess student learning.

Course Student Learning Outcomes

- 1) Proficiency in basic level sight singing
- 2) Proficiency in basic level melodic dictation (intervals and melodies)
- 3) Proficiency in basic level harmonic dictation (chord types and short progressions)
- 4) Proficiency in basic level rhythmic dictation

- 2) Learning fundamental principles, generalizations, or theories
- 3) Learning to apply course material
- 4) Developing specific skills, competencies, and points of view needed by professionals in the field
