## Course Information

### Course Description

Epidemiology is the study of the distribution and determinants of health and disease in human populations and the methods that describe and ultimately, improve health outcomes. This course introduces students to basic epidemiologic concepts including determinants of health and patterns of disease in populations, descriptive techniques of population health, use of health indicators and different types of data sources. Students will gain an understanding of the role of epidemiology in developing prevention strategies and policy.

## Teaching Strategies

Students are expected to be “active learners.” It is a basic assumption of the instructor that students will be involved (**beyond the materials and lectures presented in the course**) discovering, processing, and applying the course information using peer-review journal articles, researching additional information and examples on the Internet.

## Assignment and Activity Descriptions

**\*Please note: Rubrics for all assignments and activities are located on Blackboard.**

**Weekly Quizzes:** (100 points) Students will have *seven* weekly quizzes to assess course knowledge. Quizzes are timed (2-3 minutes per question) and will consist of 10 to 30 multiple choice questions, True/False or Fill in the Blank Questions. Access to quizzes will be through Respondus™ Lockdown Browser [See Other Required Materials for a list of needed equipment]. Students may use written materials as well as their textbook; however use of another electronic device is prohibited. There is a short 10 question practice quiz over ASU trivia that is not graded to make sure your Respondus™ Lockdown Browser works. These tools will be available to the student to assure accessibility. Students are highly encouraged to go through the practice quiz in advance of taking a graded quiz. This process will allow you to become familiar with the technology associated with testing and improve testing environment.

**Exams:** (200 points, 100 points each) The Exams each account for 200 pts of the total course grade. The exams are designed to test understanding of textbook material and the application of the material covered in both the textbook and lectures.

**Epidemiology Project (Steps 1-3):** (200 points: 50 points, 50 points & 100 points) This assignment is an application based assignment designed to give students experience researching and analyzing a specific epidemiological problem. By developing fact sheets, students will acquire the skills necessary for:

1. Conducting a focused literature search of published, scientific, peer-reviewed research on a specific health condition.
2. Critically reading, evaluating and comparing published scientific literature about a health condition to determine what is known, unknown and/or controversial.
3. Concisely summarizing relevant information for a target audience.

## Assignment Submission

All assignments MUST be submitted through the Assignments link in the Blackboard site. This is for grading, documenting, and archiving purposes. Issues with technology use arise from time to time.
