Course Information

Course Description

This course will provide future agricultural educators with a comprehensive overview of the components of an Agricultural Education program including the application of leadership principles with an emphasis on teaching elements of the National FFA & 4-H Organizations, interpersonal and personal skills and Leadership Development Events in a high school setting.

4. Demonstrate effective techniques for preparing students in Leadership Development Events.
5. Discuss skills and characteristics that contribute to success in Leadership Development

Events.

6. Develop techniques for teaching leadership to youth.
