### **Course Description:**

Instruction in violin/viola in a private lesson setting intended for those minoring in Music as well as Non-Music Majors or Majors interested in a secondary instrument. Course may be repeated for credit. Open to all majors.

#### **Course Content:**

Work on a variety of practices and techniques used in playing string instruments as body posture, instrument position, left hand principles, finger placement, accidentals, vibrato, bow hold, sound production, bow strokes, intonation, note reading and repertoire.

# **Course Objectives:**

- Proper instrument position and bow hold
- Develop creative and critical thinking
- Proper left-hand position and intonation
- Perform repertoire compatible with current level of playing

#### **Course Requirements and Expectations:**

- Attendance is required for this course. Any absences MUST be informed at least 24 hours in advance. Special cases will be analyzed individually.
- Students are expected to participate by actively playing their instruments and other learning activities.
- Students are expected to practice their instrument daily and demonstrate weekly progress.

#### **Student Assessment**

Specific items that will be assessed include, but are not limited to tone, rhythm, articulation, intonation and musical expression. Student will also be evaluated on their attendance, punctuality and preparedness.

# **Grading**

Lesson Grade (20%) - Students will receive a grade for each lesson (0-10), based on their readiness for the lesson.

Live Performances (30%) - Each student is required to perform at least 1 time in a Studio Class and 1 time in the Student Recital. Freshman, or students taking this course for the first time may be excused from performing in a Student Recital.

Final playing exam (40%) - Consists of a playing exam with selected repertoire and techniques from course material. Music minors will perform to a faculty jury panel during finals week.

Attendance (10%) - Students are expected to attend to all lessons. Each unexcused absence will lower your grade by 5 points. Two absences imply a lower letter grade at the end of the semester.
