Attendance Policy

Students in the Big Band and/or Combos are allowed two excused absences throughout the semester. Absences must be excused by Dr. Shuey before 10:00 am the morning of the rehearsal. Each unexcused absence will result in the final grade being lowered by one letter grade and a \$50 reduction of the scholarship. Excessive absences will result in dismissal from the ensemble. All performances are mandatory. An absence of any kind from a performance will result in an "F" for the semester and dismissal from the ensemble. Unforeseen circumstances are understandable, and the instructor must be notified as soon as possible. Only extreme circumstances will allow for an absence from a performance to be excused. Two unexcused late arrivals will result in an unexcused absence, hence a lowered grade.
