COURSE DESCRIPTION

This course provides the opportunity for non-music and non-voice majors to develop the fundamentals of vocal technique through in-class performance and practice.

COURSE OBJECTIVES

- Explore the voice through vocal exercises and repertoire
- Prepare and perform required repertoire
- Practice performance skills to build confidence
- Develop warm-up and practice skills
- Gain awareness of good vocal health

MATERIALS

Practice room. You will be expected to practice outside of class. If you do not have access to the practice rooms, let me know.

Audio Recorder. You are required to record your in-class performances. Please bring a smartphone or recording device to do so.

COURSE ACTIVITIES

Repertoire. Each voice student will learn, memorize, and perform three pieces by the end of the semester. These songs will all be provided to you.

In-class performances. There will be three in-class performances. Every student will perform by memory with the piano accompaniment.

Area Voice Recital. You are required to attend the Area Voice Recital on April 12th. Please put this date in your calendar and plan accordingly.

Practice. You should be practicing at least 4 days a week, usually in the realm of 15-30 minutes of singing per session. Please do not save all of your practicing for the day before or of class. This leads to vocal fatigue, frustration, and zero progress. Improvement comes from consistent practicing!

Journal Assignments. There are 5 journal entries required throughout the semester. Please see the attached sheet for due dates. Details about each assignment will be given later. All entries should be

emailed by midnight of the due date. They can be emailed up to 24 hours late for half credit. Entries emailed later than 24 hours after the due date will receive a zero.

Performance Dress. All singers are required to look their best when singing in any public performance. Women should wear a nice dress, skirt and blouse, or pant suit. Men should wear a button-down shirt with slacks. A suit jacket and/or tie is also appropriate. No jeans, sneakers, or flip flops on in-class performance days.

COURSE POLICIES

Attendance Policy. Regular and punctual attendance is required. You are allowed two free absences throughout the semester on a non-performance day. Participation Points. For each class, you are expected to participate. Participation includes, but is not limited to: commenting on the reading, engaging in class discussions, volunteering to sing (being called on to sing does not count), asking questions during the masterclasses, etc... Each time you participate in a class, you receive 1 percentage point. You can receive a maximum of two percentage points per class. If you come to class and do not participate and just sit quietly the whole time, you earn no participation points.
