## **Required Text**

## **Course Description**

This class will discuss the history and style of music from the Baroque to modern eras.

## **Purpose**

Through the study of music history, students will cultivate cultural literacy, as well as develop a greater understanding of the context in which our world operates today. Musical style will be examined in the historical context through the study of various notable genre, composers, and works.

## **Major Course Objectives**

- -Gain factual knowledge regarding terminology, chronology, classification, and trends
- -Gain a broader understanding and appreciation of intellectual and cultural activity
- -Develop skill in expressing oneself orally or in writing

### **Student Learning Outcomes**

The student will:

- -demonstrate and apply appropriate knowledge and skills in Music History that is consistent with what is used by professionals in their discipline
- -describe the general characteristics of each stylistic period in music history
- -identify composers and representative works from each of these periods
- -identify and discuss the different genres of music and their respective pace in Western music history

#### **Student Assessment**

Student learning outcomes will be measured by periodic exams and quizzes consisting of: a listening portion, a written portion (multiple choice, matching, short answer) and short essay. Students will also be assessed through completion of biweekly study guides, additional online assignments and a written research paper.

### **Class Evaluation**

This class will cover Chapters 15-28 of the Hanning. Each week will be spent discussing a new chapter, and this information will be reinforced through periodic exams and completion of study guides.
