**Non-Major Piano Class:** Piano class will cover basic technique and theory skills as applied on the piano. We will cover basic rhythmic and note reading, piano technique and keyboard methods, scales, chord playing, ensemble playing, and technical exercises, and improvisation. By the end of the semester the student should have the ability to read and play basic piano music and gain a better understanding of pianistic techniques and practice habits.

**Piano Class 1-4:** Level 1-4 are core course requirements for those pursuing the education music degree. The course is designed to fulfill the Texas state piano proficiency requirements and grants a secondary instrument as piano. Over the course of 4 semesters students will become proficient in scales, chord progressions, sight reading, harmonization, improvisation, technique, and accompaniment patterns, and repertoire performance.

**Assessment:** Will be based on a points system that will be translated into standard letter grades.

A=90-100%

B=80-89%

C=70-79%

D= 60-69% F=59% or below

#### **Grade weighting.**

**50%=Daily Grades.** You will receive 10 points per class for participation and practice. Failure to participate and practice will result in -3 points per infraction such as, leaving early, phone checking, no book, working on unapproved materials.

**50%= Playing tests.** This is broken down as follows: Final 20%, Midterm, 20%, other tests 10%.

**Assignment Schedule:** Assignments are introduced in class and posted on blackboard.

**Grading Rubric:** Grades are based on demonstration of skills. These include correct: notes, fingerings, tempo, pedal, dynamics. Each error results in –6 points out of 100. Individual Skills may be penalized per infraction. Half penalties may be deducted for errors that are accidental rather than resulting from not being prepared.

**Passing out of piano class:** For those students who are already proficient in piano and wish to demonstrate this, they may pass out of piano class. This must be done in the first month of piano class 1. After that deadline, there can be no future attempts. The course must then be completed from level 1-4.
