## Course Information

## **Student Learning Outcomes**

This course is designed to familiarize the student with the processes, principles, and theories involved in Physical Geology. The student will how to carefully defend their thinking when answering questions and with their writing. Learning outcomes will be evaluated by homework, journal posts, quizzes, and exams. At the end of this course, the student will be able to:

- 1. Describe the scientific method and apply it in a geological context.
- 2. Describe Earth's major systems and explain how they interact.
- 3. Identify common rocks and minerals and interpret how they form.
- 4. Describe and interpret the development of landforms and geologic structures.
- 5. Explain the plate tectonic theory and explain its relationship to earth processes, features, and landforms.
