# **Course Description**

Twelve-week, full-time clinical experience provided in a wide variety of health care settings. The experience is structured to provide the student with the opportunity to develop advanced skills in the management of patients with chronic conditions that require long term rehabilitation management.

#### **Grading System**

Course grades will be dependent upon completing course requirements and meeting the student learning outcomes.

The following grading scale is in use for this course:

Clinical Practicum III will be graded on a pass/fail basis. Only the grade of "Pass (P), "Fail" (F), or Incomplete (I) will be recorded on the student's transcript. Credit is given if the course is passed, although the GPA will be unaffected by the "P" grade. The "F" grade will impact the GPA as any failing grade does. The DCE has the ultimate responsibility for assigning grades.

# **Teaching Strategies**

Students are expected to be "active learners." It is a basic assumption of the instructor that students will be involved discovering, processing, and applying the course information using peer-review journal articles, researching additional information and examples on the Internet, and discussing course material and clinical experiences with their peers.

- No Red Flags or Significant Concerns on the Clinical Performance Instrument (CPI) at Final Evaluation.
- The student's comments in the CPI must support evidence of true self-reflection including strengths and opportunities for improvement.
   Copying and pasting previous comments is unacceptable and will result in remedial assignments or possible failure. The ACCE has final ruling on this subject.
- Completes all clinical assignments in a satisfactory manner and are posted to Blackboard on time.
  - Mid-term and final self-assessments using the Clinical Performance Instrument are due at the scheduled time for the Mid-term visit during (week 6) and Final evaluation (submit by Friday of week 12) of student performance. For each day submission is late, 5 points per day will be deducted.
  - Weekly Activity Logs & Goals (Appendix 24) should be completed each week and the signed document posted to Blackboard by Monday of the following week. Week 12 weekly log and goals should be posted by Friday of Week Twelve (12).
  - The APTA Physical Therapist Student Evaluation: Clinical Experience and Clinical Instruction (Appendix 3) the Mid-Portion (pages 3, 7, & 8) should be ready for review by the faculty member during the site visit and posted to Blackboard prior to the mid-term onsite visit. If the site visit will be handled by phone, the evaluation must be submitted to the ACCE by the end of Week Six on Blackboard. The Final completed form is due on Blackboard the Friday of Week Twelve (12). The student should complete the form and review it with the CCCE and/or the CI prior to leaving the facility. Failure to submit appendix 3 will result in a failing grade for the experience.
  - Reflective Practice Journal (Appendix 25). Weekly journal entries must be submitted to Blackboard electronically by the Monday of the following week.
     Final week journal entry is due by Friday of <u>Week Twelve (12)</u>.
  - Special Project (Appendix 23) Post to Blackboard by Friday of Week Eleven (11).
  - Discussion Board (Appendix 26) assignments are due on Saturday at noon. Students are expected to write an original response and respond to another student's posting for one case per week.
  - Mastery level on Assignments: Assignment that are tardy will receive ½ point value up to 1 week past due date. Assignments turned in later than 1 week will not receive credit. Mastery level of 80% is expected on each individual assignment average for successful completion of Clinical Practicum III.
  - Students who do not meet mastery on written assignments may be required to do remedial work at the discretion of the ACCE. Students may be prohibited from attending class until all work has been submitted and the student has received a passing grade

# **Student Responsibility and Attendance**

- 1. Students are expected to arrive at the clinical site on time and prepared for the day. Tardiness will not be tolerated. A second unexcused tardiness will place the student on first clinical probation. See Clinical Probation Policy, Clinical Education Handbook, page 17. Examples of excused tardiness include: congested traffic due to an accident, mechanical failure of vehicle, and a personal emergency that requires immediate attention. In the event of potential late arrival to the clinic, the CI and ACCE should be contacted by phone or other established means of communication.
- 2 Clinical attendance is required. In the event of illness, the student is required to notify the ACCE

immediately and the clinical supervisor prior to the start of the workday or at the time the illness occurs. Absence from the clinic due to illness persisting more than two (2) days during the clinical experience may require make-up time scheduled at the discretion of the clinical faculty and in discussion with the ACCE. Students may be required to follow the policy and procedures of the clinical facility regarding return to work after illness.

3 Students are expected to attend clinic every day it is scheduled. Students are expected to follow the holiday policy of the clinic, not the University, when in the clinic. Illness and personal emergencies are the only excused absences after contacting the CI and the ACCE. Absences for other reasons are considered unexcused. The first unexcused absence will place a student on First Clinical Probation. See Clinical Probation Policy, Clinical Education Handbook, page 17.

**Online**: This class is asynchronous, meaning you do not have to be on-line at a certain time. In order to complete this course successfully, you do have to participate in all course activities i.e. discussion boards, course projects, reflective logs, etc. Students are expected to engage in course activities and submit work by due dates and times. The hope is that students will make substantive contributions which reflect integration of assigned materials as well as any outside readings as appropriate. Scholarly contribution is an expectation. For planning purposes, this class will probably require a minimum of 4-6 study hours per week on average.
