Course Description

This survey course of U.S. history explores the social, economic, cultural, political, military, and legal history of the United States from Reconstruction to the modern era. From the Jim Crow South to the Gilded Age to the Progressive Era to the modern wars and changing social systems, African Americans, Immigrants and Native Americans continued to evolve into the changing framework of the United States and its existing European based culture.

Course Requirements and Grading

<u>Major Grades</u> - Unit Exams and Projects are 60 % of your grade. Exams will be given at the conclusion of each unit. Exams will consist of objective questions, short answer questions and essay questions.

<u>Daily Grades</u> - Homework and Quizzes are 40 % of your grade. Homework will consist of note-taking and document analysis. Daily grades can also be awarded based on class discussion. Quiz will consist of objective questions. Daily grades provide students practice with critical-thinking/analytical skills.

Students will be required to maintain a US History spiral notebook in order to take and organize course notes and resources. As a college level course, it is imperative that students learn note-taking strategies for both outside reading assignments and listening/participating in class lectures/discussions.

Students will be required to use their Google Classroom for assignments, quizzes and unit calendars. It is strongly suggested that students utilize unit calendars in planning/preparing for class as assignment due dates and exam dates are posted here.

Students must complete required reading assignments from the textbook and supplemental materials. Quizzes will reflect both outside reading assignments and class lectures/discussions.

Students with excused absences will have 1 calendar day per absence to make up daily and/or major grades.

Students are expected to turn in assignments on time. Late work is deducted -20 points per day it is received late.
