#### **Chapter Reviews:**

For each chapter that we cover, you will find a chapter review sheet on "Blackboard" under "Assignments" to fill out and turn in on the dates listed on the calendar. Each chapter review will consist of fill-in-the-blank sentences that come straight from your textbook as well as some review questions. The last day to turn them in for credit is the date on the calendar. *The reviews are due before or on the date on the calendar, and no late chapter reviews will be accepted.* 

#### **Internet Psychology Activities:**

During the course of the semester, you will be assigned to do <u>9 internet psychology activities</u> for credit. The due dates are on the Calendar on Blackboard. **No late activities will be accepted.** 

#### **Discussion Board:**

You will have 6 Discussion Board topics to post your responses to, and the dates for those postings are listed on your calendar on Blackboard. The due dates are on the Calendar on Blackboard, and **no late postings will be accepted.**
