## **Course Description**

This course serves as an introductory course for welding and metalworking. The course lecture and laboratory will present the student with basic knowledge and fundamentals of welding and metalwork. Importance of safety within agricultural mechanics settings will also underlie course content and design.

## **Student Learning Outcomes**

Upon completion of this course, students will be able to:

- 1. Demonstrate safe laboratory procedures in welding and metalwork.
- 2. Identify properties and procedures in metal joining, cutting and bending.
- 3. Display proper set up and use of oxyacetylene, SMAW, GMAW and plasma arc equipment.
- 4. Exhibit different types of welds using those procedures.
- 5. Recognize weld discontinuities and defects.

## **Course Delivery**

This course will be a FACE TO FACE course. WE will be able to meet all at the same times for lecture and lab without splitting into groups.

## **Technology Requirements**

#### **Evaluation and Grades**

#### Metallurgy research paper =100 pts

Students will be responsible for writing a one-page single spaced research paper (500 words) on an assigned topic dealing with metallurgy. Students will select from a list of topics.

#### Project Design plans=100 pts

Students will be responsible for designing and drawing scaled plans for a metal project. A bill of materials must accompany these plans. You will also present these projects in class for viewing of other students.

#### Exams=100pts each

Three exams will be given throughout the semester as announced. Each will cover only the material presented since the last exam. Format will typically be multiple choice and short answer.

#### Lab Attendance=200 pts

No laboratory will be made up!!! Attendance is mandatory!!! Attendance will count for half of your lab grade.

#### Lab Assignments=100pts

These will make up approximately a  $\frac{1}{4}$  of your lab grade. There will be an assignment for each lab and each will be worth 10 points.

#### Lab Project=100pts

This will comprise the rest of the points for the lab portion of this class. A project will be due at the end of the semester and will be graded for its quality of workmanship and design.
