Teaching Strategies

Students are expected to be "active learners." It is a basic assumption of the instructor that students will be involved (**beyond the materials and lectures presented in the course**) discovering, processing, and applying the course information using peer-review journal articles, researching additional information and examples on the Internet, and discussing course material and clinical experiences with their peers.

Assignment and Activity Descriptions

Weekly Lectures: 7 x 10 points = 70 points

Each week I will post an online lecture. The online lectures will be short introductions to the materials for that week and not full lectures on the chapters from the book. Each lecture will have questions embedded, totaling 10 points for the lecture. Weekly lectures are due Sunday night at 11:59 pm., the week they are assigned.

Weekly Discussions: 7 x 30 points = 210 points

Our weekly discussions will vary depending on the materials we are currently studying. Some weeks you will only need to post once, and others will need to post and respond to your classmates. Look closely at each week's description and grading rubric in Blackboard. Weekly discussions are due Sunday night at 11:59 pm., the week they are assigned. NOTE: Derogatory, harassing, or attacking post will result in a 0 for this grade and may result in failing or being removed from this course. See A Note on Discussions under Assignment Submission.

Weekly Quizzes 7 x 30 points = 210 points

Each week you will have a quiz over the chapters covered that week in class. The quizzes are in an open book and open note format. The quizzes will have 60 questions and will be limited to 90 minutes to complete, but you will have two opportunities to take each quiz, with the higher grade being the grade recorded in Gradebook. Weekly Quizzes will be due Sunday night at 11:59 pm., the week they are assigned.

Case Discussions 5 x 20 points = 100 points

We will have 5 Case Discussions during the course. Each Case Discussion will have a case presented, and you will be expected to post a new thread with your supported opinion on the case. Your supported opinion post must be at least 200 words and have at least one reference to support your opinion. Your initial post will be worth 10 points. You will then comment on two other classmates' initial posts. Your comments on your classmates' posts must be at least 50 words, and each will be worth 5 points. Specific grading of all posts will be in the grading rubric on BlackBoard. NOTE: Derogatory, harassing, or attacking post will result in a 0 for this grade and may result in failing or being removed from this course. See A Note on Discussions under Assignment Submission.

Current Events 5 x 20 points = 100 points

You have five opportunities to submit articles on current cases, laws, or other ethical issues related to this class that you find in the news or other verifiable sources published in the last year. Each submission must be on a different topic or law. Your submission must start with the reference in APA format of the item. You will then discuss the item in a minimum of 300 words noting the importance of the item and your opinion of the item. See the Grading rubric in BlackBoard for grading details. Current Events may be submitted anytime, but all five are due on Sunday, May 8th, 2022, at 11:59 pm.

Case Presentation 70 points

Each student must submit a Case Presentation. The case submitted will be of the student's choice but must be related to healthcare. Students may use cases referenced or discussed in the textbook. Cases may not be more than 10 years old.

Case Presentation Format

- 1. **Title**. Each case is given a title that signals the type of case about to be reviewed.
- Citation. Students may wish to research cases cited in this text in order to gain a deeper understanding of the topics covered. A case citation describes the identity of the parties in the case, the text in which the case can be found, and the year in which the case was decided.
- 3. **Facts**. A review of the details of the case.
- 4. **Issue**. The issues discussed in any given case are selected for review on the basis of medical and legal importance to the healthcare professional. Although any one case may have multiple issues, only those considered pertinent are reviewed here.
- 5. **Holding**. The court's ruling based on the facts, issues, and applicable laws pertaining to the case.
- 6. **Reason**. The rationale behind how the court arrived at its decision based on the facts, issues, and relevant laws surrounding the case.

7. **Discussion**. Discussion questions, although prompted by a particular case, may not necessarily be germane to the facts of the case. The questions are merely presented as opportunities for discussion about the issues raised in the case and do not add to the facts of a specific case.

Understanding Case Citations

A *case citation* identifies the parties in the case, the text in which the case can be found, and the year in which the case was decided. For example, consider the citation *Boulia v. Superior Court (Glenchur)*, 225 Cal. Rptr. 297 (Cal. Ct. App. 1986):

- Boulia v. Superior Court (Glenchur) identifies the basic parties involved in the lawsuit.
- **225 Cal. Rptr. 297** identifies the case as being reported in volume 225 of the California Reporter at page 297.
- Cal. Ct. App. 1986 identifies the case as being decided in the California Court of Appeal in 1986.

For this assignment, example discussion questions and a grading rubric are available on BlackBoard. The Case Discussion must be a minimum of 500 words and will be due on Sunday, May 8th, 2022, at 11:59 pm.

Mid Term and Final Exam 120 points each = 240 points

The Mid Term and Final Exams will be comprehensive and will be taken on Respondus Lockdown Browser. Both exams are closed book and closed note. Students are not allowed to use any source of reference during the exam, including but not limited to: books, notes, electronic devices, other persons either in proximity or electronically. Using any source of information other than your mind will result in a 0 on the exam and may result in failing the course. Each exam may only be taken once.

Assignment Submission

All assignments MUST be submitted through the Assignments link on the Blackboard site. This is for grading, documenting, and archiving purposes. Issues with technology use arise from time to time.
