# **Course Description**

This course is an introduction to comparative behavior between human and non-human animals with a consideration for the conservation of behavior across species. Focus will be given to the evolutionary process and its influence on neurology, learning and cognition, behavior (generally) and social behavior especially among primates.

#### **Graded Forum Discussions**

- 1) At the end of each module three to four discussion questions covering the information from that module as forum questions/statements will be presented. The question or statement may occasionally describe a hypothetical situation and ask for a hypothetical response. These "discussions" should be considered mini research papers rather than a casual conversation. The guidelines for what will be expected in the discussion are:
  - You are to select **one** and <u>only one</u> discussion topic to answer for each module. Once selected, you will write a logically constructed essay of at least 400 words but not to exceed 700 words. This is not an exercise in opinion wielding. In other words, treat your response like you would a research paper. claim.
  - Answers must be supported by empirical evidence, from either the book or other reputable (preferably peer reviewed) sources.

    Anecdotes are not evidence.
  - This is not a creative writing course, so remember that every claim/assertion made in your essay must have a citation or it will be considered unsupported conjecture.
  - Answers are to be submitted as a thread in the discussion forum by 11:59 pm the Sunday of the week in which it is posted. The instructor reserves the right to use plagiarism prevention software. Each answer will be graded based on a total possible point value of 100 (400 possible points).
  - Lastly, you must also comment on at *least* one (1) other students' answer by noon the following day (Monday)— failure to do so will result in an automatic loss of 20 points. Comments are to be civil and professional in nature and address the substance of the answer (e.g., NOT "I really liked your answer" or "I agree with everything you say").
- **2)** Each week I will post a mini discussion for everyone to engage. These discussions are not graded per se, however there is 100 points in participation/engagement that will be factored into the final grade

#### Communication

Faculty will respond to email and/or telephone messages within 24 hours during working hours Monday through Friday. Weekend messages may not be returned until Monday.

**Written communication via email:** All private communication will be done exclusively through your ASU email address. Check frequently for announcements and policy changes. In your emails to faculty, include the course name and number (Comparative Psychology, 6316) in the subject line.

**Virtual communication:** Office hours and/or advising may be done with the assistance of the telephone, Collaborate, Skype, etc. Additionally, there may be virtual "lecture" sessions through Zoom. This would be exploratory for feasibility. You will receive additional information regarding virtual lecture possibilities.

"Netiquette": Forum posts should be professional in nature. You will be expected to engage in forum activities with your classmates. The topic of this course can be very polarizing and impassioned, which can result in vigorous conversation which is perfectly acceptable in the context of this class. However, there is no tolerance for hate speech, name calling or adhominin attacks. We will engage in respectful conversation at all times.

#### **Teaching Strategies**

Students are expected to be "active learners." It is a basic assumption of the instructor that students will be involved (**beyond the materials and lectures presented in the course**) discovering, processing, and applying the course information using peer-review journal articles, researching additional information and examples on the Internet, and discussing course material and clinical experiences with their peers. This is especially true of a graduate class.

This is an online class and as such is largely self-paced.
