### Course Information

#### Course Description

The course is a graduate-level course, where capturing images and processing them are discussed. The main concentration of the course is on improving image quality for making it better suitable for extracting information. The information extraction from images is discussed in low, mid, and high levels are discussed.

The main expected outcome of the course is providing the students with the capability of understanding main image processing applications, and what challenges we may face using them in real-life.

The goal of this course is to introduce image processing applications. The image representation, information extraction from images, and the challenges are discussed.
