Course Information

Course Description: Application of mathematical principles to the analysis of engineering problems using linear algebra and ordinary differential equations (ODE's).

Textbook: *Notes on Diffy Qs: Differential Equations for Engineers* by Jiří Lebl. This is a free online book available here: https://www.jirka.org/diffyqs/. Prerequisite Courses: Mathematics 2415 (Calculus II) or equivalent.

Course Delivery: This is a face-to-face course with online components that students are expected to access in <u>Blackboard</u>.ⁱ

MyOpenMath: The free electronic resource MyOpenMath will be used in this course. To access MyOpenMath, click the various homework links in Blackboard. You DO NOT need to purchase access.

Technology Requirements: This course will be using the free online homework system MyOpenMath. This homework system requires a somewhat modern computer with reliable internet access. The computer lab in MCS is available to students, if needed.

Communication: Most email will receive a response within 24 hours during working hours Monday through Friday. Please include your course name (Calculus III, Finite Math, etc.) in your messages for the quickest reply.

Course Content: The following chapters and content will be covered.

1. Integrals as solutions, Slope fields, Separable equations, Linear equations and the integrating

factor, Autonomous equations, Numerical methods: Euler's method.

2. Second-order linear ODEs, Constant coefficient second-order linear ODEs, higher-order linear

ODEs, Mechanical vibrations, nonhomogeneous equations, forced oscillation and resonance.

A. Vectors, mappings, and matrices, Matrix algebra, Elimination, Determinant.

3. Intro to systems of ODEs, Linear systems of ODEs, Eigenvalue method, Two-dimensional systems

and their vector fields, Second-order systems and applications, Multiple eigenvalues,

Diagonalization.

4. Boundary Value problems, The trigonometric series

comprehensive final exam is in-person on paper.

Homework (20%): Homework will be completed online in Blackboard using MyOpenMath. You are

welcome to receive help on homework from any source: me, students, solutions manuals, online, etc.

However, it is encouraged that you work the homework on your own first, since this will be the best way

to practice for tests. Homework is always due at 11:59pm on the day it is due.

Students will demonstrate factual knowledge of the mathematical notation and terminology used in this course. Students will demonstrate the ability to read, interpret, and use the vocabulary and symbolism of differential equations and linear algebra.

Students will be able to describe the fundamental principles arising from the concepts in this course. Students will demonstrate familiarity with the concepts that follow from the fundamental concepts; for example, existence of solutions to differential equations, properties of matrices and vectors, properties of vector spaces and subspaces.

Students will be able to apply the course material to solve problems. Students will use the facts, formulas, and techniques to solve first and second order differential equations and systems of differential equations, and to

manipulate matrices and vectors.

Students will develop specific skills, competencies, and reasoning abilities to support further study or work in this or related fields. Students will acquire a level of proficiency in the fundamental concepts and applications necessary for further study in engineering.
