#### **Prelab Videos (300/1600)**

Students are required and responsible to complete watching the video and answering the questions built into the video prior to the Monday classes by 12 PM, except the first week video due by Wed 11:59 PM.

#### **Weekly Quizzes (350/1600)**

Sectional quizzes will be opened on individual Wednesdays and close on the same Sunday at 11:59 PM. There are 7 sections, 50 points for each with 5 to 10 questions.

#### **Lab Activities (300/1600)**

Lab activities will be assigned each week. Students are required to submit the lab report by each Wednesday at 11:59 PM.

#### Pre-learning Presentation (50/1600)

This presentation is to help the instructor to understand students' background knowledge regarding modality and clinical reasoning. Students will require to complete a SOAP (subjective, objective, assessment, and plan report) on ATrack and present their rational with their interventions. Students will present one of the case they experienced in the current semester clinical rotation.

#### Final Case Study Presentation (200/1600)

Each student will receive a case scenario on the second week. According to the scenario's pathological stage and modalities introduced in this course, students are required to implement a protocol to the assigned case and present it in the class in a conference style. The presentation needs to include: 1) introduction of the scenario, 2) summaries of peer-reviewed journals evidence (at least 5 articles published within the past 5 years), 3) suggestions from at least 2 mentors' interviews, and 4) a treatment plan with critical rational. #### Final Written Exam (200/1600)

The final written exam will be taken place on Wednesday, May 11<sup>th</sup>, at 1:00 PM. It will be performed on a lockdown browser with the Board of Certification examination style.

#### Practical Exam (200/1600)

Each student will receive a case scenario and require to incorporate the knowledge of modalities to choose an appropriate intervention with clear rationale and communication skills. Each student has 60 minutes exam window. In the first 30 minutes, each student will study the case scenario and write down the modality/parameter/rationale...on a paper. In the last 30 minutes, the students will perform the modality on a patient and explain the protocol to the instructor. See the <u>Practical Exam Grading Rubric</u> for detailed information.

This course is graded strictly on points NOT percentages. The amount of points you earn determines your grade in the course. I DO NOT ROUND UP GRADES at the end of the semester. It is your responsibility to keep track of the total course points you have accumulated and take advantage of the bonus points available in the course.

All exams are closed book in class examinations. This means you are expected to take all exams on the scheduled date under the supervision of the instructor.
