Catalogue Description

The study of the organization, administration, current practices, drill writing, and appropriate literature for the high school marching band. Application of concepts included.

Prerequisite

Successful completion of MUSI 2311 or permission of the instructor.

Rationale

Marching Band Techniques will focus upon establishing effective techniques for teaching and leading a marching band program in schools for students in grades 9 - 12. Goals and objectives will be established and completed through prescribed strategies and activities. Collaboration and group projects will be designed in addition to individual assignments.

Course Goals and Outcomes

During this course, students will:

- 1. Discuss all aspects of show design, including musical selections, color guard choreography, drill design and movements, and implementation of ideas;
- 2. Select music that is appropriate and effective for the high school curriculum;
- 3. Design multiple appropriate drills for musical selections. The drills will vary in group size, difficulty, and requirements;
- 4. Analyze and evaluate multiple marching band shows;
- 5. Learn and use computer programs and applications relevant to marching band;
- 6. Discuss ways to begin and increase participation in a high school marching band program;
- 7. Using the information learned, combined with personal experience, develop a half time show including musical selections, costumes and props, drill designs and movements, and musical aspects that will be taught throughout the marching season.

Required Materials

Marching Band Techniques Handbook, Available from the instructor. Pyware Drill writing software. (We will discuss how to acquire this software.)

Course Outline/Schedule

A schedule has been provided. The schedule may be adjusted at any time based upon the needs of the class. The professor has several professional engagements throughout the semester that may require his absence from class. Electronic and remote assignments will be used to supplement instruction when these events occur.

Attendance Policy

Students will attend class regularly. Each student is allowed one unexcused absence throughout the semester. Excused absences must be approved by the instructor at least 4 hours before the start of class. The instructor will determine if the absence is to be excused. If the student is sick, he/she should not attend class. He/she should complete the daily wellness screening and go to the health clinic. Documentation from the clinic is required for the absence is to be excused. After the first, each unexcused absence will result in a one letter reduction of the final grade. Tardies are unacceptable. If the student arrives more than 5 minutes late, he/she will be considered absent for that class period.

Strategies/Assignments

- Assignments will be assigned throughout the semester to enhance the learning experience and are designed to recreate real life experiences students will encounter upon entering the profession. Assignments are due at the beginning of each class period. Late submissions will not be accepted. Student work will be evaluated based upon a rubric that has been developed by the professor. Specific instructions and rubrics will be provided to the students when the assignment has been made. Assignments will also be uploaded to Blackboard. All written assignments will be submitted through Blackboard.
- Readings. Students will be assigned regular readings throughout the semester. These readings have been included on the course schedule. Students are expected to arrive to class having read the assignments and prepared for discussion in class.
- *Guard Silks.* Students will design guard silks to be used in the final project. Included will be a color drawing, measurements, patterns, and a detailed list of patterns needed to create the silks.
- Drill Assignments. Drill assignments will be made throughout the semester and be arranged progressively toward the final project. These assignments will be completed electronically and submitted during class. Evaluation will be based not only upon the quality of work, but also upon the student's ability to follow instructions, and participation. The instructor is aware that the majority of students have little to no experience writing drill.
- *Show Concepts.* Students will 4 develop simple show concepts with musical selections that can be used for the final project if desired.
- Show Proposal. The final project of the course is to design a halftime show. Students will select music, write 15 pages of drill, design costumes, guard silks, and props (if desired), and present the show to the class at the end of the semester. This project should be a culmination of all concepts learned throughout the semester.

Grading

The final grade will be determined by total number of points earned throughout the semester.
