Grading

Policy: Major exams (4) will be worth 60% of your grade. The final exam will be worth 40% of your grade. No grades will be dropped.

Note Taking: It is imperative you take thorough notes on all class lectures and discussions.

Attendance: Being in class is conducive to maintaining good grades. Habitual absenteeism is not. Points will be added to or subtracted from your grade as follows: Perfect attendance - add 5 pts. 1-3 unexcused absences - add 3 pts. As regular attendance is necessary to achieve student learning outcomes, it is the policy of the History Dept. that missing more than 20% of the course (9 absences) will result in a reduction of one full letter grade when calculating the final course grade. Excused absences include school sanctioned events, serious illnesses or emergencies. If possible, please let me know in advance if you plan to be absent. Excused absences do NOT apply towards perfect attendance except under extenuating circumstances.

Make-ups: Should you miss an exam or quiz due to an absence, you will have one opportunity to take a make-up. That will be on Fri., April 22 during regular class time. Please make every effort, not only to be in class, but also to be present during an exam or quiz. Should you miss a lecture, due to an absence, it will be your responsibility to obtain the information that was covered on that day. That means get the notes from someone in class.

1. "Religious Holy Day" means a holy day observed by a religion whose places of worship are exempt from property taxation under Texas Tax Code 11.20.
2. A student who tends to observe a religious holy day should make that intention known in writing to the instructor prior to the absence. A student who is absent from classes for the observance of a religious holy day shall be allowed to take an examination or complete an assignment scheduled for that day within a reasonable time after the absence.
3. A student who is excused under Section 2 may not be penalized for the absence, however, the instructor may respond appropriately if the student fails to complete the assignment satisfactorily.
