## **Course Description:**

This is the second semester, specialized course designed for undergraduate students in choral music education. Students will examine the role and responsibilities of the conductor, analyze the relationship between gesture and sound, and refine and focus their fundamental conducting skills towards the choral vein. Topics discussed in this course include but are not limited to: conducting technique, musical terminology, score study, and expressive and effective conducting.

## **STUDENT LEARNING OBJECTIVES:**

Students will refine conducting techniques including: posture, basic patterns, preparatory gestures, dynamics, cuing, left hand independence, and musical expression.

Students will develop conducting techniques with and without the baton.

Students will demonstrate fundamentals of score study, including basic terminology.

Students will be able to critically examine their own, their peers, and professional conducting techniques.

## Conducting Excerpts

I want to give you quality experiences in front of the ensemble. Thus, we will spend two weeks per piece. The goal is you conduct once, refine, and conduct a second time.

\*\*You must learn the melody and other vocal parts so we create a "lab chorus" setting. Your grade will be affected by preparation for your own assignment, as well as being able to sing your part for your colleagues.

#### **Midterm and Final**

In addition to the chapter excerpts, you will be asked to prepare larger musical examples for the midterm and final. The final may consist of one or two contrasting examples but is contingent upon time allotment. These excerpts will provide each of you the opportunity to conduct a larger body of literature in preparation for the second semester of conducting and "real life" expectations.

#### **Attendance**

<u>Students are allowed one unexcused rehearsal absence per semester</u>. Excused absences do not count against this one unexcused absence. Students must remain in rehearsal or the performance until it has concluded to receive full credit.

## **Conductor Observation Paper**

Ideally, you would observe two live performances or rehearsals and analyze each conductor. However, due to COVID-19, you will be asked to observe virtually. Please select one orchestral conductor and one choral conductor to discuss. We will examine this assignment in greater detail during class time. Should you need additional conductor suggestions, I will be happy to assist. Topics to include in your paper include but are not limited to:

Conductor posture, stance, arm position, facial expressions, and conducting area.

Discuss the style of the piece and how the conductor reflects this style.

During the performance or rehearsal, does the conductor change anything about their conducting to reflect or represent the sound they would like to hear? Does the ensemble respond? Discuss anything else you may observe during the rehearsal as it pertains to the conductor and the ensemble performance.

## **RECORDING**

To facilitate your personal progression and development as a young conductor, it is crucial to record, watch, analyze, and reflect. Please use your phone or tablet to record yourself as you conduct. You will be able to take this home and reflect upon your gesture along with my comments and suggestions.
