Course Overview

<u>Course Description (From catalog):</u> An examination of the methods and statistics commonly used when conducting research in applied settings. Topics will include qualitative data collection and analysis, quasiexperimental designs, organizational survey research, longitudinal designs and program evaluation.

Course Requirements and Assignments

<u>Homework Assignments:</u> Over the course of the semester you will complete 8 homework assignments and they will each be worth 25 points allowing you to earn 200 points from homework. In general, the assignment will be given in class and will be due the following class period. Please see the attendance policy above if you will not be in class to submit your homework.

Re-Do Option: Throughout the semester, everyone will have one chance to re-do a homework assignment if they would like to improve their grade. You will only be allowed *one* re-do and the assignment must be submitted by 04/27.

<u>Final Exam:</u> On 04/27, you will be given an in-class final exam which will assess your learning of the material presented throughout the semester. More specifics about what types of questions to expect will be given in class. The exam will be worth 100 points.

<u>Semester Project:</u> Over the course of the semester you will work with a large data set to come up with hypotheses and to test those hypotheses using techniques learned in class. There will be several deliverables associated with this project:

<u>Hypothesis List:</u> First, you will look through the data set and codebook to identify variables that interest you. From there, you will come up with a list of hypotheses (around 8-10) about those variables. This portion will be worth 25 points and is due on 03/23.

<u>Presentation:</u> On 05/04, each of you will give a brief (10 minute) presentation to the class detailing your hypotheses and analyses. More information about the specifics of the presentation will be given in class. This portion is worth 75 points.

<u>Final Paper:</u> Lastly, you will complete a full, manuscript style write-up of the analyses you have done. You will detail the variables you chose, your proposed hypotheses, the analyses you have conducted, any graphs or figures, and provide a full results section. This paper will be in APA style. More specifics and a detailed rubric will be given in class. The final paper portion of the project will be worth 100 points and will be due 05/09 by 11:59pm.
