#### **Course Description**

The integrative seminar in social work. This capstone course facilitates the integration and application of the generalist social work curriculum in diverse, evolving, and emerging practice contexts. Student career development, use of technology, and professional leadership are emphasized. As a part of this course, students must take and pass a comprehensive examination, and must develop and present a portfolio.

# **Grading**

#### **Evaluation and Grades**

**This is a pass/fail course.** Students must pass the comprehensive exam with a minimum score of 70%. Student portfolios will be evaluated by a faculty panel and will be assigned a passing or failing grade. **Students must receive passing scores on both the comprehensive exam and the portfolio to pass the course.** 

#### **Teaching Strategies**

Students are expected to be "active learners." It is a basic assumption of the instructor that students will be involved (beyond the materials and lectures presented in the course)

discovering, processing, and applying the course information using peer-review journal articles, researching additional information and examples on the Internet, and discussing course material and clinical experiences with their peers.

#### **Assignment and Activity Descriptions**

#### **Comprehensive Examination**

Each student will successfully complete the social work comprehensive examination. The exam covers the following broad areas of generalist social work practice:

- I. Human Development, Diversity, and Behavior in the Environment
- II. Assessment in Social Work Practice
- III. Direct and Indirect Practice
- IV. Professional Relationships, Values, and Ethics

This exam strives to measure your social work knowledge, skills, and values related to the EPAS 9 competencies and 31 behaviors. There are 170 items of the examination, and you will have four (4) hours to complete the examination. You will have three attempts during the semester to achieve an acceptable score (70) on this examination. An acceptable score is required to pass this course and for graduation from ASU's B.S.W. program.

#### **Student Portfolio**

Each student will assemble a portfolio which will include the student's resume, samples of the student's work in the B.S.W. program, and additional assignments. Portfolios will be evaluated by faculty and assigned a passing or failing grade. Portfolios will include submissions from core social work courses as well as work related to field and general professional development.

#### **Assignment Submission**

All assignments MUST be submitted through the Assignments link in the Blackboard site. This is for grading, documenting, and archiving purposes. Issues with technology use arise from time to time.
