### Course Description

This course provides an extensive overview of responsibilities, duties, and behaviors within the coaching profession. It addresses competencies necessary for administration and management in coaching. The course will provide the study of both X-O's and the non-X-O components required of most sport coaching positions.

## Teaching Strategies

Students are expected to be “active learners.” It is a basic assumption of the instructor that students will be involved (**beyond the materials and lectures presented in the course**) discovering, processing, and applying the course information using peer-review journal articles, researching additional information and examples on the Internet, and discussing course material and clinical experiences with their peers.

## Assignment and Activity Descriptions

**\*Please note: Rubrics for all assignments and activities are located at the end of this syllabus.**

COURSE REQUIREMENTS:

- 1) Develop a 15-minute video of sport instruction.
- 2) Choose an “X-O” book related to sport of interest and create an outline of said book for others. Two formats of outline are required. (a) formal detailed outline for the instructor; (b) an abbreviated outline for all your class cohort members.
- 3) Develop a Professional Resource Manual that must include:
  - a) 10 sport websites
  - b) 5 available clinics and workshops
  - c) 10 additional “X-O” sport specific books
  - d) 5 non-“X-O” coaching books each covering a specific coaching issues (ie: equipment management, turf management, sport fundraising, etc.)
  - e) 5 sport related theses
  - f) 5 sport related dissertations
  - g) 5 related sport research journals.
  - h) 5 sport specific and 5 administration issue related DVDs and/or videos
  - i) 10 sport specific articles
  - j) 10 non-“X-O” articles related to coaching administration (ie: recruiting, booster club oversight, etc.). No more than 2 articles on any one issue.
  - k) 5 available related coaching associations
  - l) Information on 5 instructional coaching education programs to include: PACE, ASEP, NYCA, plus 2 more.
  - m) **All sections** are expected to be done in **detail**. Copies of each article, for **sections i and j**, are to be included, not just the title author, journal and volume year. Additionally, each article should be read and high-lighted.

- n) **Section I** should include a complete narrative summary of the 5 programs. For **all other sections** follow APA guideline procedures.
- o) Participation in reflection papers and (or) discussion boards on chapters or topics from class.

**COURSE PROCEDURES:**

- 1) All work is sent via email attachment to the instructor (ssnowden@angelo.edu) by 3:00pm every Friday.
- 2) The specific weekly projects listed below are to be sent to each member of the class cohort.
  - a) Resource Manual Information. A slight exception is you do not have to send the copies of the various articles you have copied and read for your own manual to everyone. Instead you may send the summary info: Article Title, Author(s) name, journal source info of name, volume year and page numbers (just like a reference page in an APA manuscript. Thus, each student will be responsible to compile all the related information per section into their final resource manual.
  - b) Abbreviated "X-O" book outline related to your video coaching clinic.
  - c) Copy of your video coaching clinic (each student will be expected to submit a narrative evaluation and grade for each video project on the Monday after week 3 project due date.
- 3) **Any work not properly forwarded on to class cohorts will result in a loss of one letter grade minimum from the final course grade.**
- 4) Students in the immediate area are requested to turn in the hard copy of their Resource manual to the instructor on the due date. Those students out of state must submit their manuals either by mail or electronically via email attachment.
