Next generation web. Web of data and knowledgebases. Efficient management and use of web data. Metadata standards, XML, RDF, OWL and metadata processing; ontologies, semantic web applications.

Required Use of Masks/Facial Coverings by Students

As a member of the Texas Tech University System, Angelo State University has adopted the mandatory [Facial Covering Policy](#)¹⁰ to ensure a safe and healthy classroom experience. Current research on the COVID-19 virus suggests there is a significant reduction in the potential for transmission of the virus from person to person by wearing a mask/facial covering that covers the nose and mouth areas.
