Course Information

Course Description

We will be going into great depth on concepts of population genetics, and quantitative genetics, working through the theory and applications of these concepts—application, meaning, discussing and working through these concepts to show how they are meaningful, and how they are to be used in today's livestock breeding systems.

Prerequisites

Some foundational bit of understanding, and a strong interest in the application of genetic principles to livestock breeding, with the use of some basic statistics concepts. Some prior course(s) in, or at least some amount of experience in animal breeding, and fundamental statistics would be a great booster to the student's learning experience in this course, but is not necessary, or required upon taking this course.

Student Learning Outcomes

Students will fluently understand the theory, and livestock breeding applications of population and quantitative genetics, upon taking this course.
