# **Course Description**

This course investigates the effects of illness and health on the community. Students will examine the current demographic information of local communities as it relates to community planning and public health.

- 6. Perform direct and indirect methods of standardization.
- 7. Construct and analyze simple and abridged life-tables.
- 8. Describe the relations and calculate indicators in a stationary population
- 9. Derive the mathematical relationships in a cohort life table.
- 10. Estimate the rate of change in a population
- 11. Project a population using appropriate equations and assumptions.
- 12. Recognize and analyze typical demographic patterns arising from the data.

# **Teaching Strategies**

Students are expected to be "active learners." It is a basic assumption of the instructor that students will be involved (**beyond the materials and lectures presented in the course**) discovering, processing, and applying the course information using peer-review journal articles, researching additional information and examples on the Internet, and discussing course material and clinical experiences with their peers.

# **Assignment and Activity Descriptions**

**Exams:** Access to the Midterm and Final Exam will be through Respondus Lockdown Browser and will be video recorded via Respondus Monitor [See Other Required Materials for a list of needed equipment]. Both will be timed at no more than 120 minutes. Use of any assistance or other electronic device is prohibited. A thorough environmental scan is necessary to ensure adherence. Cheating on an exam will result in failure of the course. Leaving the room during an exam should not occur.

Material for exams will come from lecture recordings, textbook readings, supplemental materials, and companion website. Makeup exams are contingent to the presentation of a valid excuse according to the student's manual and University regulations.

**Readings:** You are responsible for the material covered in the book prior to attending class. Please note that the week's readings are specified in the class schedule on the following pages. In addition to these readings, the instructor may assign supplemental readings throughout the semester. These supplemental readings do not appear on the schedule, as these readings will be assigned at the instructor's discretion.

**Quizzes:** Weekly online quizzes will be given throughout the semester and will require that you read and respond to material in the textbook as well as revisit topics discussed in class. Access to quizzes will be through Respondus™ Lockdown Browser [see Other Required Materials for a list of needed equipment] via Blackboard. Students may use written materials as well as their textbook; however, use of another electronic device is prohibited.

There is a Readiness Quiz, which will serve as a webcam test and will give you an opportunity for bonus points. These tools will be available to the student to assure accessibility. Students will have multiple (3) attempts to complete the practice quiz. This process will allow you to become familiar with the technology associated with testing and improve testing environment. Instructional videos and more information regarding Respondus Monitor can be found under the Respondus Monitor Help tab in your Blackboard course.

**Homework:** Students will be responsible for the completion of three written homework assignments. These assignments will be used as opportunities to

implement topics and theories taught in class. These papers are to be written in poper APA format, standard 12-point Times New Roman font, double-spaced with 1-inch margins. A rubric for written work will be used for grading

#### **Writing Center**

The mission of the <u>Writing Center</u> is to help all students become better writers and readers. The Writing Center is a peer tutoring service where students help students. It is staffed by specially selected and trained graduate assistants and peer tutors who offer one-on-one conferences about writing and reading. The Writing Center serves all ASU undergraduate and graduate students. They work with students from any discipline, at any skill level, and on any stage of the writing or reading process.

The Writing Center tutors also provide feedback on scholarship, job, or graduate school applications. You can send writing questions via email to the Writing Center by completing and submitting the electronic draft submission cover sheet. You must properly cite any work that is not completely your own. It is understood that you will build on the ideas of others through research, reading, and collaboration, but failure to acknowledge the scholarship of others is plagiarism and an honor code violation. It is also understood that you should use direct quotes sparingly. In this course, we would like you to use the Publication Manual of the American Psychological Association, Sixth Edition.

A good resource is <u>Purdue's University OWL Lab</u>. These OWL resources will help you learn how to use the American Psychological Association (APA) citation and format style. This section contains resources on in-text citation and the References page, as well as APA sample papers, slide presentations, and the APA classroom poster: <u>APA 7<sup>th</sup></u>.

#### Note on Wikipedia

You can use Wikipedia as a starting point for your research; however, it should not be used as a primary reference. Please use the online health science curated resources such as <u>Pubmed</u>.

#### **Assignment Submission**
