Course Description

Introduction to the scientific study of factors underlying behavior. In addition to the physiological bases of behavior, other factors such as intelligence, learning, motivation, emotion, and perception are covered. In this course, you will learn to understand human behavior from various perspectives, think scientifically, and apply concepts to daily life.

Course Delivery

This is an online course offering. This course will be delivered online via Blackboard and the course can be accessed using ASU's Blackboard Learning Management System. Textbook: *Experience Psychology* (3rd or 4th edition) by Laura King (ISBN: 9781259818912). *Be Advised:* The book, *The Science of Psychology,* by Laura King looks very similar to the required text. Double-check the title of the text.

Technology Requirements

Testing with LockDown Browser: In order to complete the exams and quizzes, you must have the Lockdown Browser on your computer. Go to blackboard to the "support" tab and follow the instructions to download the browser. Once it's downloaded onto your computer, double-click on the icon in order to connect to Blackboard. Login to Blackboard and click on a quiz or exam to complete. Select "no" for the password (note: if you can't get past this point, something is wrong – the quizzes/exams are password protected, but you will NOT be given the password). Once you select no you should be able to proceed with the quizzes/exams.

**If you have any problems downloading Lockdown Browser, please contact IT (942-2911) as soon as possible to resolve technological issues so you do not miss the deadlines for these assignments. Not having the Lockdown browser downloaded in time to complete assignments will result in zeros for any assignments not completed in time.

Assignment Submission

All assignments MUST be submitted through the Assignments link in the Blackboard site. This is for grading, documenting, and archiving purposes. Issues with technology use arise from time to time. This lets your faculty know you completed the assignment on time and are just having problems with the online submission feature in Blackboard. Once the problem is resolved, submit your assignment through the appropriate link. This process will document the problem and establish a timeline. Be sure to keep a backup of all work.

Assignments

Exams: There will be fourteen online multiple-choice exams which will consist of 25 questions that will cover information presented in the textbook. Exams are open book/open notes—because of this, you are limited to one attempt unless otherwise authorized. Exam due dates are listed on the course schedule below. Exams will be made available at the beginning of the week they are due, and are due by Saturday at 11:59pm (CST) of that week. If you have planned absences and need accommodations to take an exam early, you must inform me ahead of time so I can make the exam available to you in advance (this is a Blackboard thing I must coordinate!)

Respondus LockDown Browser is required to take your exams

NOTE: Access to exams will be through Respondus Lockdown Browser and will be video recorded via Respondus Monitor. Exams are open book/ open note. You may access an eBook on another device, which you must present in the environment check stage preceding each test. Use of any other electronic devices is prohibited.

There is one practice quiz: a short 10 question, ungraded practice quiz, over ASU trivia. The purpose of this practice quiz is to ensure students can access LockDown Browser before the first exam. Students are highly encouraged to go through this practice quiz in advance of taking a graded exam. This process will allow you to become familiar with the technology associated with testing and improve the testing environment. Instructional videos and more information regarding Respondus Monitor can be found under the Respondus Monitor Help tab in your Blackboard course.

Discussion Boards: The discussion board is meant to simulate discussion of the readings and assignments that would normally happen in a traditional classroom setting. Five questions (one introduction post + four course topics) will be posted throughout the course and students will respond to each of these questions. Please note, discussion boards have two-part due dates, but the final due dates (the dates replies are due) are the only dates reflected in Blackboard. Reference the course calendar for the due dates for original posts. Your original response to the question must be posted by Thursday 11:59 pm (CST) of the current week (except for the first week, when it is due later—see course calendar for due dates). Each original response is worth 15 points. Five points will be taken off for late posts. Students also need to respond to two comments made by other students or the instructor. Each response post is worth 5 points. These responses must be completed by Saturday 11:59 pm (CST) of the due week. Students may post response posts early if other students have already commented. Any posts after 11:59 pm on Saturday will not be accepted. Students may post as many times as they like, however, only the first original post and first two responses to other students' posts will be graded.

Students must also check the discussion board and respond to comments by the instructor and other students on their original posts. Failure to answer questions that others have made about your posts will result in a loss of points. Please see the discussion board rubric for more details.

Application Activities: For each chapter, students must complete an application activity in Blackboard. These activities vary in form, with instructions accompanying each activity. Some activities will require watching videos and commenting; others require research, questionnaires, or answering questions from the text/additional readings. Guidance for each activity will be posted in the activity instructions. Each application activity is worth fifteen points, and must be a minimum of 300 words. Students must cite any and all sources used, including the course text and any assigned readings/ videos. Failure to appropriately cite resources will result in a score of zero. All application activities are due by Saturday at 11:59 pm (CST) of the current week. If you have any questions, please email the instructor.

Final Paper: The final paper will be due the last week of class, and will require you to integrate information you have learned throughout the course and apply it to life. This will be a 5-7-page paper, with APA formatting (a style guide is available on the APA website, linked in Blackboard). A grading rubric will be posted on Blackboard with more information.

Extra Credit: Extra credit opportunities will not generally be available for this course. If you have any concerns, please contact me. I may be willing to entertain a great idea, but do not count on extra credit to make up for missed or late assignments.

Research Participation: If any student research projects can be accessed online and you'd like to participate, I am willing to allocate extra credit points for research participation.
