PART 1: THIS COURSE

COURSE DESCRIPTION: Political Science 4391 is an independent study to prepare students for law school. The study is for assistance to ASU students to enable them to be prepared to succeed in studies after graduation

CORE OBJECTIVES:

Critical thinking: gather, analyze, evaluate, and synthesize information relevant to a question or issue.

Communication: develop, interpret and express ideas through effective written communication

Social Responsibility: demonstrate knowledge of civic responsibility

Personal Responsibility: demonstrate the ability to evaluate choices, actions, and consequences as related to ethical decision-making

COURSE LEARNING OUTCOMES:

- 1. The student will demonstrate knowledge about the study of law in the U.S.
- 2. The student will read law as required by the law school.
- 3. The student will identify good listening and notetaking skills for law school classes.
- 4. The student will participate in the unique style of classes for law school.
- 5. The subject is to be determined on an individual basis. The student will demonstrate knowledge of one portion of the study for one first-year law school class. The subject may not include a subject class already offered in the Political Science Department in the same semester as the independent study.

CLASS REQUIREMENTS:

Independent Study: The student should be prepared to set up a meeting schedule with the professor, agree to deadlines for submission of work, keep all meeting times and meet all deadlines absent extraordinary circumstances.

Practice taking reading notes—submit in the portal on Blackboard and bring a copy to the meeting;

Meeting be prepared to be questioned about casebook reading and answer hypos orally.

Week of April 4: Reading Like a Lawyer Part III chps 13-16; Casebook rest of chapter 1;

Complete practice taking reading notes and submit through the portal on Blackboard and bring a copy to the meeting;

Meeting be prepared to answer questions about and explain all hypos in reading

Week of April 11: Subject matter reading, class participation, and class notetaking exercises

Week of April 15: Subject matter and citation writing exercises

Week of April 22: Subject matter and citation writing exercises

May 1: Final exercise due; Subject matter test to be completed
