Institutional Characteristics Overview

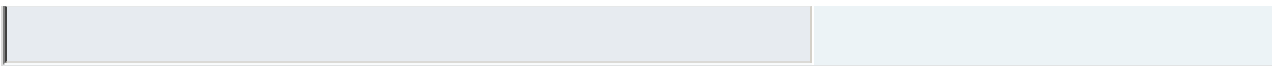
