What is Sexual Assault Prevention for Graduate Students® ?

Angelo State University is committed ensuring students receive an exceptional education and can be successful not only in the classroom but as a member of our campus community. As part of this commitment to provide a positive education experience, ASU has implemented a comprehensive training program to assist graduate students in making safe decisions related to relationships. *Sexual Assault Prevention for Graduate Students®* focuses on healthy relationships and sexual assault prevention. Sexual Assault Prevention for Graduate Students® teaches students about setting good boundaries, practicing good communication, affirmative consent, how to be an active bystander, and signs of interpersonal violence and sexual assault.

Who is required to complete Sexual Assault Prevention for Graduate Students® ?

All incoming graduate students must complete the course by the end of their first semester. Students must complete the training even if a student is not a first time graduate student, if the student took the courses at a different institution, is a non-traditional student, or if the student does not plan on drinking or having relationships while in college.

How do students know they have to complete Sexual Assault Prevention for Graduate Students® ?

- Students receive an e-mail on **July 19th** titled *"Important Mandatory Title IX Training-- Requires Immediate Attention!"* and will continue to receive e-mail communication about both Part I and Part II until the course is completed.

Where do students go to complete Sexual Assault Prevention for Graduate Students®?

- The student will need a computer with Internet access and audio capabilities;
- Next, the student should login to Rampart;
- Go to the "Campus Life" tab and click "Access Training Courses" under the heading "Required Trainings;"

When must Sexual Assault Prevention for Graduate Students® be completed?

- Part I of the course opens on **July 19th** and is due by the end of the semester.
- The student will be notified via email when Part II is available for them to complete.

How long will it take to complete Sexual Assault Prevention for Graduate Students® ?

- Part I of *Sexual Assault Prevention for Graduate Students®* will take approximately 45 minutes – 1 hour.
- Part II should take approximately 15 minutes

What is required for students to “pass” the quizzes Sexual Assault Prevention for Graduate Students® ?

A pre and post quiz will assess the knowledge students gain from each course. There is no required minimum score to pass this course, but they must be completed.

Are the responses to surveys and quizzes confidential?

All survey and quiz responses are completely confidential. ASU will only receive information about the student body’s responses as a whole in order to plan effective prevention programming. ASU will never see an individual student’s answers.

What happens if a student does *not* complete Sexual Assault Prevention for Graduate Students® ?

- The student will receive a **Grade Hold** on their account if they do not complete the trainings by the deadline. The hold will be placed before grades become available.
- The student will receive a **Registration Hold** on their account if they do not complete the trainings by their second semester on campus. The hold will be placed the last two weeks of the semester before registration open.

What happens if a student completes Sexual Assault Prevention for Graduate Students® after the deadline?

The student’s hold will be removed one hour after they complete the training programs.
